Please read the following instructions before completing this form 請在填寫本表格前細閱以下指示：

Why are we asking you to complete this form? 為何我們要求您填寫本表格？

To help protect the integrity of tax systems, governments around the world are introducing a new information-gathering and reporting requirement for financial institutions. This is known as the Common Reporting Standard (the "CRS").

Under the CRS, we are required to determine where you are a "tax resident" (this will usually be where you are liable to pay income taxes). If you are a tax resident outside the jurisdiction where your account is held, we may need to give the national tax authority this information, along with information relating to your accounts. That may then be shared between different jurisdictions' tax authorities.

Completing this form will ensure that we hold accurate and up to date information about your tax residency.

If your circumstances change and any of the information provided in this form becomes incorrect, please let us know immediately and provide an updated self-certification.

為維護稅制完整，全球各地政府現正推出適用於金融／財務機構的資料收集及匯報新規例，名為共同匯報標準（簡稱「CRS」）。

根據 CRS 規定，我們必須確定您的「稅務居住地」（這通常是您有義務繳納薪俸稅的國家／地區）。若您的稅務居住地有別於所持賬戶的司法管轄區，我們可能需要將此情況及您的有關賬戶資料告知國家稅務機關，該等機關隨後或會將相關資料傳送給不同國家／地區的稅務機關。

Who should complete the Individual Tax Residency Self-Certification Form - Entity? 誰需填寫自我證明表格- 實體?

Entity customers (which includes all businesses, trusts and partnerships except sole traders) should complete this form.

If you are an individual customer or a sole trader, complete a "Self-Certification Form - Individual" (CRS-I). Similarly, if you are a controlling person of an entity, complete a "Self-Certification Form - Controlling Person" (CRS-CP).

Even if you have already provided information in relation to the United States Government's Foreign Account Tax Compliance Act ("FATCA"), you may still need to provide additional information for the CRS as this is a separate regulation.

Please tell us in what capacity you are signing in Part 4. For example you may be an authorized officer of the business or a trustee.

Important Notes 重要提示

- This is a self-certification form provided by an account holder to Zhong Jia Securities Limited ("ZJ Securities") for the purpose of automatic exchange of financial account information. The data collected may be transmitted by ZJ Securities to the Inland Revenue Department for transfer to the tax authority of another jurisdiction. 這是由賬戶持有人向中佳證券有限公司「中佳證券」提供的自我證明表格，以作自動交換財務賬戶資料用途。中佳證券可把收集所得的資料交給稅務局，稅務局會將資料轉交到另一稅務管轄區的稅務當局。
- An account holder should report all changes in his/her tax residency status to ZJ Securities. 如賬戶持有人的稅務居民身份有所改變，應盡快將所有變更通知中佳證券。
